# **Children returning in September**

If your child is returning to the pre-school in September:

Please complete and return their funding form by Wednesday 18th July. If you haven't received this please ask a member of staff in your child's base room.

If you haven't already returned your child's Learning Journey please do so by Wednesday 18th July.

Over the summer we will be completing our annual review of the setting and some children will be changing base rooms and/or key person. If your child is having a new key person you will receive a letter informing you of this.

From September, our 2 year old children will continue to be based in Room 2; all other children will be based in Room 1 and will enter/leave through the main door by the office.

### **30 Hour Funding**

To find out if you are eligible for the 30 hours funding please go to <a href="www.childcarechoices.gov.uk">www.childcarechoices.gov.uk</a> If you are eligible you will be issued with an 11 digit code which you will need to bring in to us. We will then run a validation check, inform you of the outcome and any additional sessions can then be requested in writing or by email, and will be allocated subject to availability.

### Read, Write Inc. Activity Suggestion



When you are out and about over the summer with your child encourage them to listen attentively to the sounds within their environment. Talk to them about the different sounds that can be heard. Go on a 'Listening Walk' together. Make a list of sounds they can remember when you get home (using words or pictures). We would love to see these when your child returns in September.
